HARNESSES UNLIMITED warrants to the original purchaser that it will repair or replace free of charge any of its harnesses or parts found while owned by the original purchaser to be defective in materials or workmanship provided (a) a written notice of the defect is given to us within six (6) months of the date of our shipment, and, if requested, the defective harness or part is returned to us, and (b) the harness or part alleged to be defective has not been altered by the purchaser and, if installed in a vehicle, has been installed in accordance with our instructions.

THERE IS NO OTHER EXPRESS WARRANTY, ORAL OR WRITTEN. THERE IS NO IMPLIED WARRANTY AFTER SIX (6) MONTHS FROM DATE OF SHIPMENT.

WE SHALL NOT BE RESPONSIBLE FOR PROPERTY DAMAGE, PERSONAL INJURY, LIABILITY, LOSS, OR CONSEQUENTIAL DAMAGES, RESULTING FROM OR INVOLVING A VEHICLE IN WHICH OUR HARNESS OR PART HAS BEEN INSTALLED.

1. Download and print order form. Then on order form fill in date, your name and address (Since all shipments are made by UPS, you must give us a street address not a P.O. BOX, RD #, or RR #). Please include your telephone number and times when you may be reached in case we need additional information. Also your e-mail address if available.

2. HARNESS INFORMATION:

When ordering wiring harness sets you must fill in all vehicle information on the order form, including options or special requirements to receive the proper wiring harness system.

Wiring harness systems are not stocked items but are custom assembled per your order and options. Delivery time, from the receipt of your order varies greatly depending on the production schedule of orders already received. Production backlog can be up to 4 months.

3. SUPPLY INFORMATION:

Some supplies you order may be out of stock, for these items we will substitute a similar item (i.e. If we're out of 16 gauge red wire. we will substitute 14 gauge red. We will always use the next larger gauge in wire). All items, which are placed on backorder are shipped as soon as they are received from our suppliers. If you do not wish to substitute or backorder, please indicate refund on the order form. We will enclose your refund in the box with the invoice and your order.

4. BRAIDING SERVICE:

If you wish to use our braiding service, please call us for further information. Shipping on braiding orders is \$ 25.00 per car.

SPECIAL INSTRUCTIONS FOR OUT OF U.S.A ORDERS:

A. Fill out the order form as above except for shipping fee - shipping costs can not be calculated until the order is done and the package can be weighed due to the varying rates for each country and rapid rate schedule changes.

B. Payment options- Payment for order SUBTOTAL may be made in U.S.A. funds by bank check and enclosed with the order form with shipping costs billed when the order is done.

Or send the order form without payment then when the order is done and shipping costs can be calculated, payment may be made by wire transfer for the Total. The total includes the order, shipping costs and a \$ 16.00 bank wire transfer fee. If you do not wish to do a wire transfer you may send a check in USD.

NO C.O.D. orders will be accepted.

C. All shipments will be made by U.S.A. Postal Service with the appropriate customs papers. WE WILL NOT MAKE ANY FALSE DECLARATIONS ON CUSTOMS PAPERS. This is for our mutual protection from legal action by the governments involved and possible seizure of order. We will use the lowest cost Air service where we can insure the package for its full value.

D. We must have your telephone number and call times so customs can contact you if needed.

E. If your country requires an import license for entry you must get the import license in advance. The custom forms must show the number before we can ship the package.

REFUND POLICY

We will give a full refund (at original invoice price - shipping fee is not refundable) at anytime for any of our standard products returned unaltered. Any product that we altered extensively per customer request or any custom harness built per customer drawings may not be returned for a refund.

Any standard product that is returned damaged, soiled, or altered (our determination) shall have the cost of repairing the product to our original specifications deducted from the original invoice price for that item.

To return a product for a refund, you must call us for shipping instructions. Include in the box with the product, a note explaining reason for return, a copy of the invoice, your telephone number and your mailing address. Returns will not be accepted if shipped C.O.D.

PRIVACY POLICY

Any information given on the order form is used only to process your order and to deposit funds. We do not use this information for any other purpose. We do not release your information to any other company or entity. Also it is our policy not to do bulk mailings of any kind.
